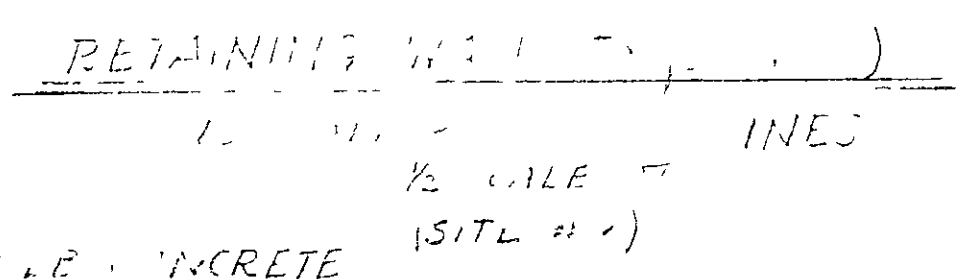
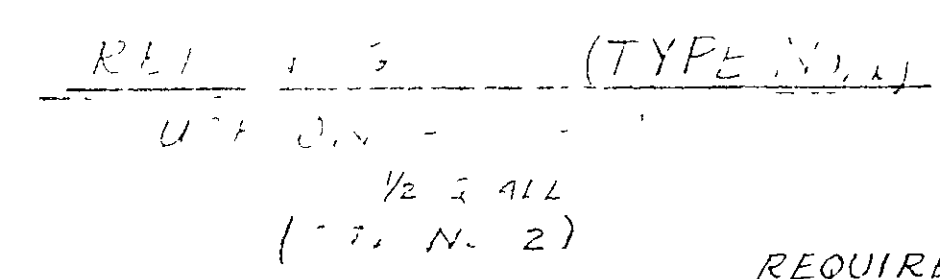
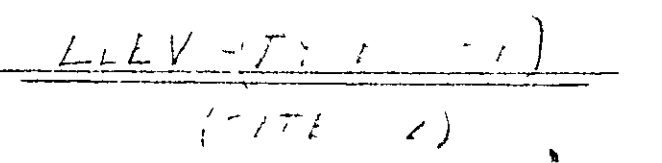


DETAIL OF CONTRACTION & EXPANSION JOINTS RETAINING WALLS NO SCALE



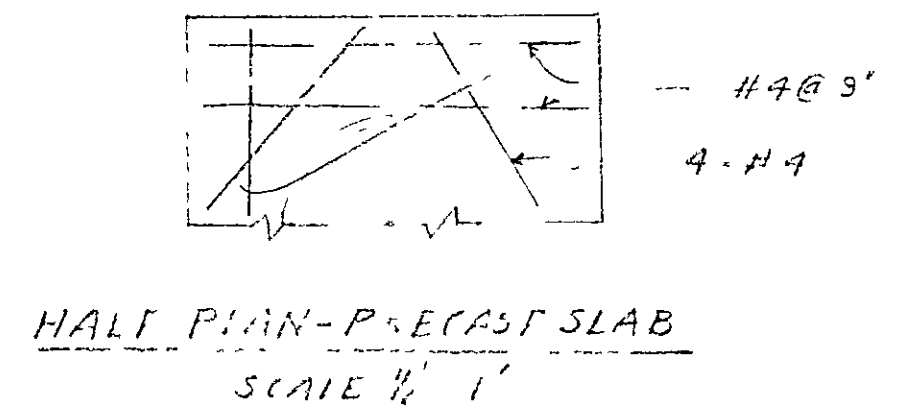
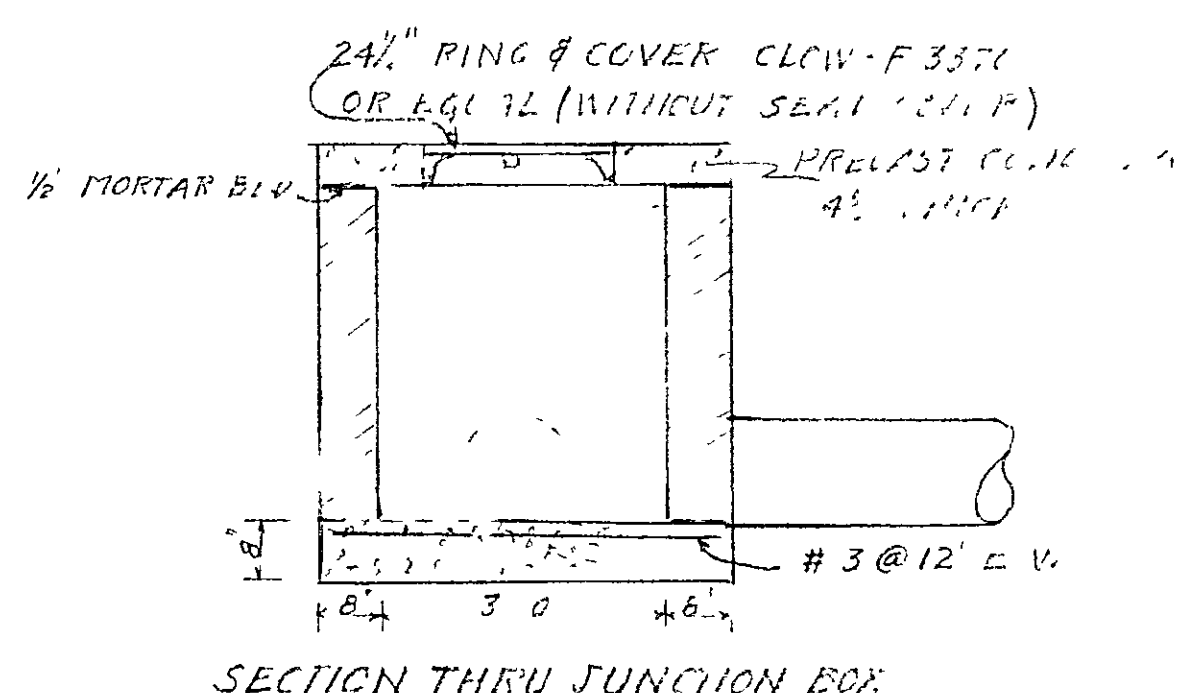

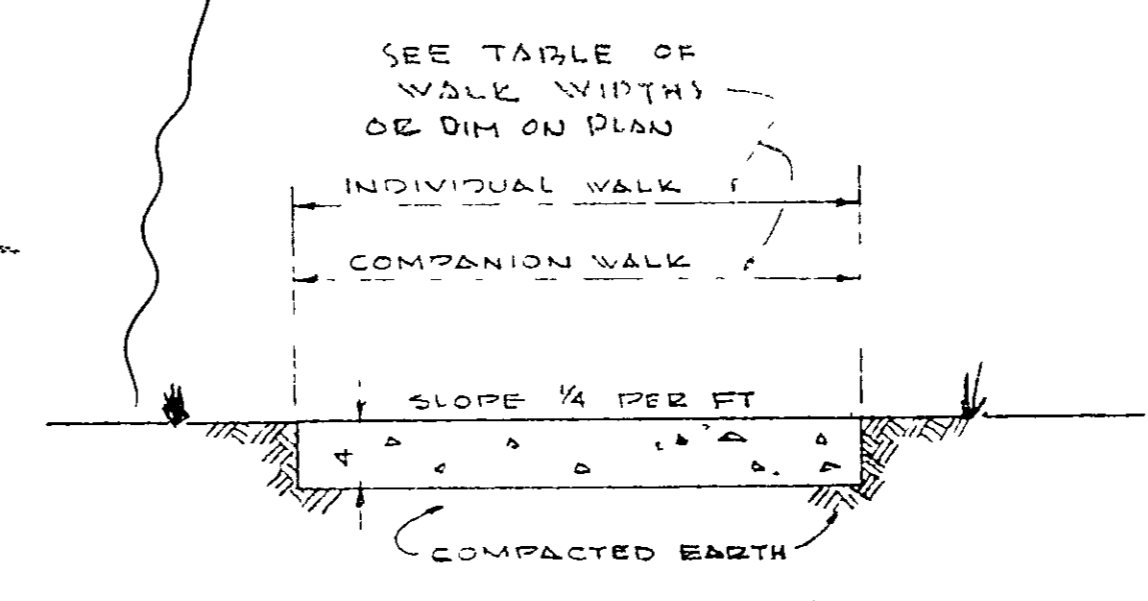
TYPICAL SIDEWALK PLAN

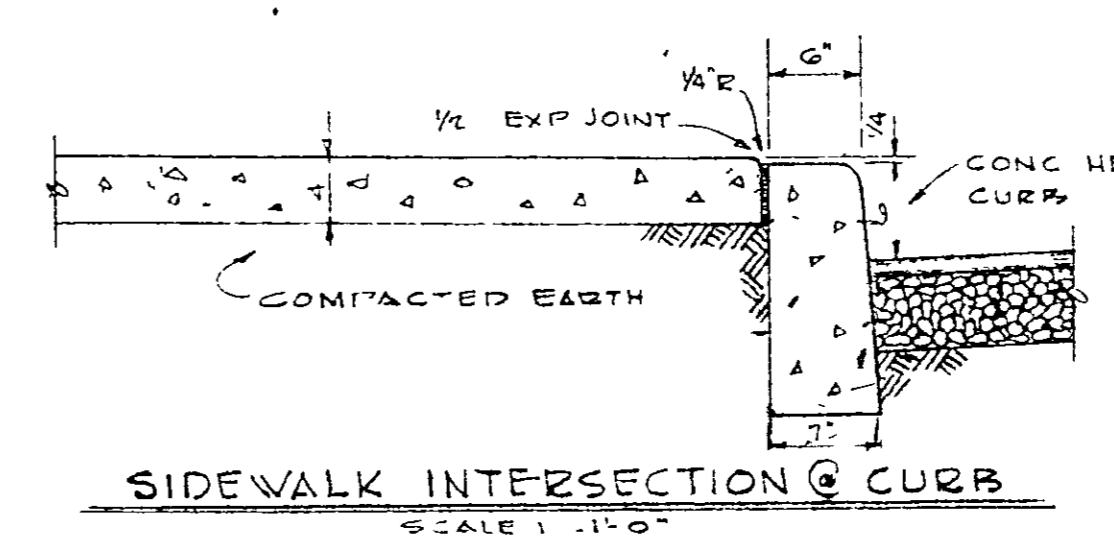
PLAN AT SIDEWALK INTERSECTIONS

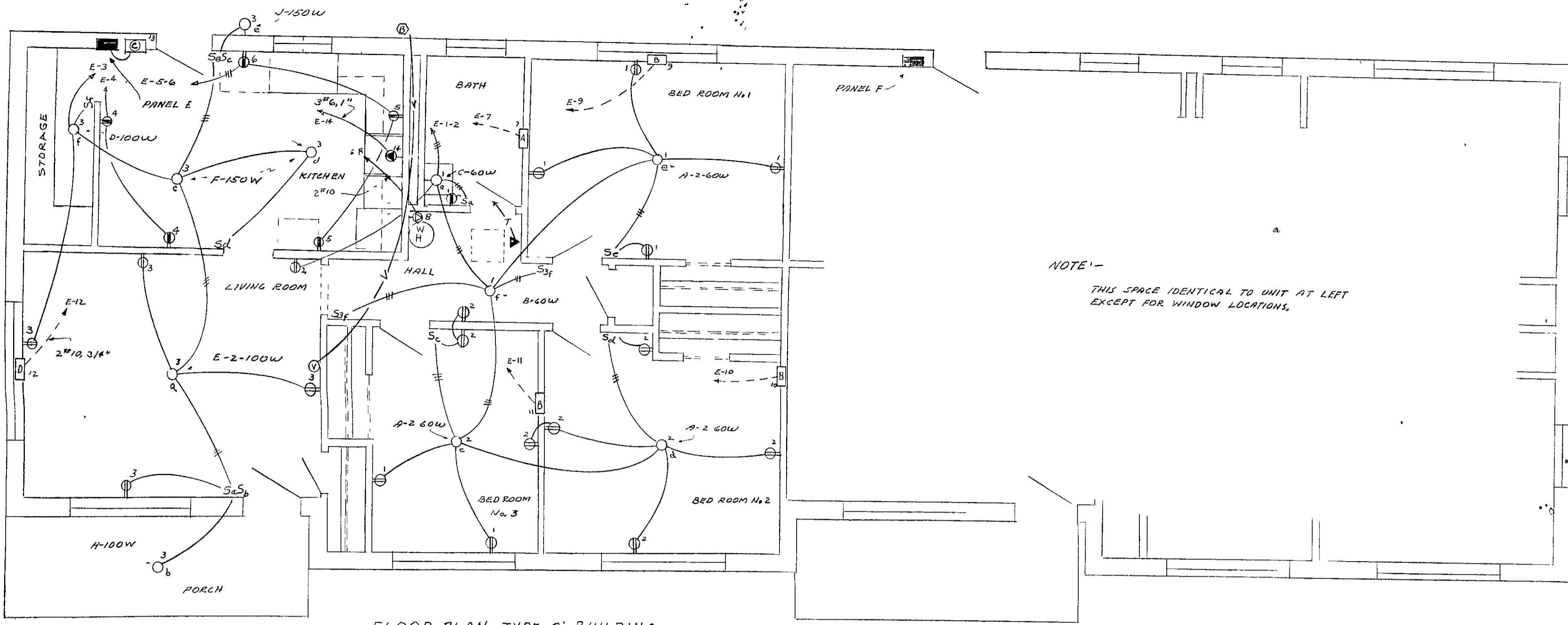
RISER DIAGRAM - TYPE A & B BUILDINGS
